Parents were invited to attend the Parent Involvement Policy and Parent Compact meeting to give their input. A robo call was sent to parents via school messenger inviting them to this meeting. Only one parent showed for the meeting which occurred on October 12th, 2017. Suggestions and input from the parent were provided which have been incorporated in the current Parent Involvement policy and Parent Compact.

2. The <u>John Bartram High School</u> will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

Parents take an active role by serving on the School Improvement and Leadership Team.

This team meets monthly to discuss and review student achievement, academic progress, instructional practices, student attendance and punctuality issues and graduation information. We will discuss special programs and various academic activities scheduled to take place. The School Advisory Council and Home and School Association provide opportunities for parents and faculty to become involved in school improvement planning and assessing effectiveness of programs establishes actions steps

and responsibility charting. A budget meeting was held on March 28, 2017 with administration, leadership team, PFT building representative, roster chair and parents to review the 2017 budget. All information was compiled to aid in the development of the Action Plan effective Spring 2017. Parental Volunteers, Beautification Committee, Parental Newsletter Committee, and PAD Desk are other means by which our parents become involved. Parents have agreed to provide six hours of community service to the school during the school year.

- 3.  - Regional PREP parents will serve as advisors to principals and SAC members on how to address the needs of students and parents in their school's Action Plan and Title I Budget.

These results will be reviewed and shared with the staff during PD on December 8th, 2017. John Bartram High School administration and staff will work together to develop a strategy to improve parent involvement. Counselors will also be planning workshops for parents starting after December 2017.
- 6. Professional Development will be held on December 8th, 2017 to educate all staff in strategies that they can use to effectively work with parent and guardians. Staff will be given tools to use in order to reach out to parents (school messenger system, SIS information, mailing, etc..) in order to properly communicate with parents and guardians to keep them abreast of current information, programs and meetings.

Teachers meet weekly as part of their grade group meetings for common assessment planning. Teachers have a prep/admin period on Fridays to make parent phone calls and send parent emails. This information is uploaded onto a google doc which is monitored by the principal. All teachers are required to contact 5 parents each week with updates regarding their child and any school events that will be coming up.

D. The John Bartram High School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

Monthly Distribution of Principal's Newsletter: Principal's Newsletter is distributed via email to staff. Morning announcements are made daily to inform students of upcoming events. Robo calls are sent out monthly to inform parents of information.

Counselor's Corner Monthly Publication: This information will be available under the school's website counselor's link to keep students and parents informed of different programs and upcoming events.

We do not have a Parent Resource Room; however, we do have resources for parents in our library. We do have a PAD desk that is full of information to help parents support their youth. Parent information can also be found in the main office and on our school's website which is updated as needed.

Newsletters are printed in Parent Friendly Language. Our school uses school messenger and Bartram's website as a communication vehicle to share information with parents. The school has the services of the district and division in providing information to parents in different languages. Translated materials if needed, are available with support from Office of Language, Culture and the Arts. If parents do not understand any of the materials, they may reach out to our Counselor.
